FINANCIAL



LOANS & MORTGAGES:

Information on PAOC sources that are available to churches in the fellowship who are in need of financial loans and mortgages.



MISSIONS GIVING:

Missions giving remittance resources.



PAR:

Information and registration for the PAOC PAR Program. PAOC can administer a Pre-Authorized Remittance (PAR) program for your church, where church offerings are given by automatic monthly debit from individuals' bank accounts. The PAOC can accommodate up to three giving options: General, Missions, and Other. Fee: \$1/transaction.



PAYROLL SERVICES:

Information and registration for PAOC payroll services. PAOC can process your church's payroll for only \$7.50 a pay period. We can process pays for salaried employees whether they are full-time or part-time on the following schedules: Bi-weekly (every other Thursday), Semi-monthly (15th and 30th) or Monthly (15th or 30th).

PENSIONS

PAOC offers Defined Benefit (DB) and Defined Contribution (DC) pension plans. PAOC provides governance and oversight over both plans to ensure our values are instilled in investments and operations.

DEFINED BENEFIT

Established in 1938, the PAOC Pension Fund is a multi-employer, defined benefit pension plan, federally incorporated, and registered in the various provinces across the country. Led by a Board of Trustees appointed by the General Executive of the PAOC, administration is coordinated through the International Office, with a dedicated Pension Centre team available to answer any questions.

A secure way to save for retirement, the Fund offers a 10% benefit ratio, meaning that at age 65 years a retiree can expect to receive an annual pension equivalent to 10% of total contributions made over the years.

Enrollment is open to:

- a) Credential holders with full-time employment in a PAOC church, ministry, or affiliate.
- b) Non-credential holders with full-time employment in same, who are members of a PAOC assembly or would qualify for membership.
- c) Part-time employees in the same categories, under certain conditions.

FOR CHURCHES AND EMPLOYEES ON OR CONSIDERING THE DEFINED BENEFIT PLAN, THE FOLLOWING FEATURES ARE AVAILABLE:

- Retirement income stream is predetermined based on employer and employee contributions.
- During periods of market uncertainty, retirement income is stable.
- Option at time of retirement to make provision for a lifetime spousal pension for a qualifying spouse, in the event of a member's death.
- PAOC mission is supported through investments in church/ministry mortgages.



DEFINED CONTRIBUTION

BMA Benefits is a consulting firm, tasked with the design and implementation of the DC Pension Plan, in conjunction with PAOC and Canada Life. Services provided include no-cost individual financial advising for all PAOC DC plan members and their families.

Enrollment is open to:

- a) Credential holders with full-time employment in a PAOC church, ministry, or affiliate.
- b) Non-credential holders with full-time employment in same, who are members of a PAOC assembly or would qualify for membership.
- c) Part-time employees in the same categories, under certain conditions.

FOR CHURCHES AND EMPLOYEES NOT ON THE DEFINED BENEFIT PLAN, THE DEFINED CONTRIBUTION PLAN OFFERS THE FOLLOWING:

- Lower fees than if administered by the church and/or employee.
- Offloading of administration and liability to BMA Benefits.
- Support of PAOC mission through investments in church/ministry mortgages, once DC portfolio achieves critical size threshold.
- Professional personal financial advice for staff at no extra charge.







PFSG was established in 2005 with the main objective of providing mortgage funding to PAOC churches for construction projects. PFSG is wholly owned by PAOC.

We currently process \$3.99 million in gross pay for more than 100 employees in PAOC churches and related ministries across Canada.

Whether you have one or several employees... we provide direct deposit and online paystubs every pay period.

Our Fees are super low:

- For I to 5 employees the cost is \$7.50 per pay period.
- For 6+ employees the cost is \$1.50 per employee per pay period.
- For Hourly employees the cost is \$2.50 per employee per pay period.

Other fees are:

- Record of Employment reports cost \$2.50 per request.
- T4 Drafts at year-end cost \$2.50 per employee.
- That's it, there are no other fees!

We provide all the information you need for:

- · Monthly financial reporting.
- Remitting source deductions.
- Filing Records of Employment.
- Filing year-end T4's.

We process pays for salary and hourly employees on these schedules:

- Bi-Weekly: Sunday to Saturday. Paid every other Thursday.
- Semi-Monthly: 1st to 15th and 16th to end-of-month. Paid on the 15th and 30th.
- Monthly: Calendar Month. Paid on the 15th.
